1. In your response below you state that: "The clerk of each court is the keeper of the court's seal."

a judgment from the Superior Court of California and I needed to prove that judgment for use in another country for child support or other money-judgment, Hague or non-Hague, there must be a central location that can authenticate the signatures and seals of the courts in each county.
28 USC 1738 describes the manner for proving records for use within the United States:
The records and judicial proceedings of any <u>court</u> of any such <u>State</u> , Territory or Possession, or copies thereof, shall be proved or admitted in other <u>courts</u> within the United <u>States</u> and its Territories and Possessions by the attestation of the clerk and seal of the <u>court</u> annexed, if a seal exists, together with a certificate of a judge of the <u>court</u> that the said attestation is in proper form.
However, I cannot find how to authenticate a judgment from the Superior Court WITHOUT the United States for enforcement in a foreign jurisdiction. With this in mind I am requesting any/all records relating to the authentication or exemplification of records generated by the Superior Court of California for enforcement abroad.
