IN REGARDS TO: CANCELLATION OF THE VOTER REGISTRATION FOR: YOUR NAME

I wish to cancel my voter registration for one or more of the following reasons:

- I believe that voting is an act of violence - it polarizes people and creates divisions. We should all be working together on common causes.
- My vote doesn't count –Researchers at Princeton University looked at 20 years of data to answer one question: Does the Government represent the people? What they concluded was “the preferences of the average American appear to have only a miniscule near zero statistically non-significant impact upon public policy”. So my belief that my vote does not count is supported by research. In fact if my vote did count you can be sure that voting would be illegal!
- I believe that Government is a parasite and participates in legal plunder. A good example of this is between 2010 and 2015 the top 200 politically active companies spent 5.8 billion dollars influencing the “government”. Those same companies got 4.4 trillion dollars back in US tax dollars. Additionally, it was the tax payer who paid to bail out the banks who caused the crash of 2008 and forced millions of Americans from their homes, a practice that continues to this day!
- I will not vote for a lesser evil because they are all evil! In regards to the last election a Reuters/Ipsos online poll found that 46% of voters who would support Clinton in a head-to-head matchup against Trump say they are primarily backing her because they don't want to see the business mogul become President, compared to 43% who say they agree with most of Clinton's political positions. Similarly, 47% of voters who plan to back Trump say they're doing so because they don't want Clinton in the White House, compared to 40% who agree with most of Trump's positions. I don't want anyone to represent my best interests as no one will defend my interests better than me.
- I do not support bombing other countries nor acts of international nor domestic. It is a violation of international law for me to consent to cooperate with any government which

produces, possesses or uses nuclear weapons. International law imposes a duty upon individual citizens to disassociate themselves from violations of such law since the Nuremberg principles have become a part of international law, the notion of individual responsibility for war crimes has achieved wide acknowledgement. Under the Nuremberg Charter, it is no defense to claim one was merely following orders. Nuremberg Charter, supra, Art. 7. Individual responsibility attaches if “a moral choice was possible”. Ex Parte Quirin 317U.S. 1 (1942). My participation in the election farce is a choice; and I choose not to participate.

The United States is a corporation and was created under the act of 1871, see title 28 Sec 3002 (15)(a)(2) which states that the United States is a federal corporation without the consent of the people – if one participates in an election as a United States citizen then one commits a crime pursuant to section 2 of the fourteenth amendment to the Constitution of the United States. Such crime is perceived to be treason, which is based on the breach of allegiance to one’s lawful state government. My allegiance is to my family, and to the people and not a federal corporation.

I do not consent to the perversion of what was intended to be a limited form of government.

I do not consent to a clipped sovereignty. In America the people are sovereign: “at the Revolution, the sovereignty devolved on the People; and they are truly the sovereigns of the country, but they are sovereigns without subjects and have none to govern but themselves; the Citizens of America are equal as fellow Citizens, and as joint tenants in the Sovereignty”. (Chisholm v. Georgia, 2 Dallas (U. S.) 419 @ 469, 1 L. Ed. 440 (A. D. 1793). I want the federal government evicted from my state and all their “funding” of programs stopped.
